Appendix D-Accountability Glossary

Accountability SubsetThe collection of assessment results that are used to determine district and campus accountability ratings. Only assessment results for those students enrolled in the same district/campus on both the snapshot date (the last Friday in October) and the testing date are used to determine district/campus performance.

Alternative Education Accountability (AEAT) he specific provisions by which the performance of alternative education charter schools and ampuses determined and accountability ratings are assigned. AEA is comprised of a modified graduation rate component calculation in the Student Achievement domain and modified cut ptsinacross all domain Additionally, AEA charter schools and campuses are not evaluated on School Progress, Part B and gibbe to earn bonus points.

Alternative Education Campus (AEC) campus at which at least 75 percent of students are considered at risk of dropping out of school and at least percent of students are enrolled in grades 12. Campuses must registered each year to be considered AECs evaluated under AEA provisions.

Annual Graduates: Students who graduate from a district or campus in a school year regardless of cohort. This is separate from, and may include different students than, the longitudinal graduation rates.

Asylee/Refugee Exclusion Assessment esults of students identified as unschool to unschool education and unschool to unschool to display a second to unschool to display as an unschooled asylee or refugee, both of the following criteria must be met:

The student must be identified as limited English proficient (LEP) as defined by state law in Texas
Education Code (TEC), Section 29.052 and must participate in a state-approved bilingual or English

- 3. was not advanced from one grade level to the next for one or more school years; (Note: From 2010-2011 forward, TEC 29.081-10) excludes from this criteria prekindergarten or kindergarten students who were not advanced to the next grade level as a result of a documented request by the student's parent.)
- 4. did not perform satisfactorily on an assessment instrument administered to the student under TEC Subchapter B, Chapter 39, and who has not in the previous or current school year subsequently performed on that instrument or another appropriate instrument at a level equal to at least 110 percent of the level of satisfactory performance on that instrument;
- 5. is pregnant or is a parent;
- 6. has been placed in an alternative education program in relatince with TEC §37.006 during the preceding or current school year;
- 7. has been expelled in accordance with TEC §37.007 during the preceding or current school year;
- 8. is currently on parole, probation, deferred prosecution, or other conditional releas
- 9. was previously reported through the Public Education Information Management System (PEIMS) to have dropped out of school;

School TypeA specific label given to a campus for thurposes of determining its domatiargets. The label a campus receives lementary, middle school, elementary/secondary, or high school determined by the grades served by the campus as reported in OttheberTSDSPEIMS enrollment snapshot.

SmallNumbers Analysis process to determine if a rating is appropriate for small districts and campuses that do not meet minimusize criteria using current year data.

Snapshot DateThe "as of" date that is used to determine D\$PEIMS enrollment information October 29, 2021, is the TSDS PEIMS snapshot date for t24-202 school year.
